12.\* The Executive may also charge fees from schools, which the Executive must set, subject to consumer affairs legislation and so not in consultation with the Queensland Debating Union, Greater Public Schools Debating Association or any other body.

12.\* The Executive may also charge fees from schools, which the Executive must set, subject to consumer affairs legislation.

#### 16. RESOLVED to amend Rule 51 of the Constitution from:

51. \*Persons may use electronic technology such as Internet telephony or webcams in order to participate in the meeting and communicate with other members and such members shall count as present at the meeting for the purposes of quorum.

TO:

- 51.\* With respect to General meetings:
  - (1) General meetings may be conducted either in person or by using any technology that gives the members as a whole a reasonable opportunity to participate; and
  - (2) Any person may attend and participate fully in a General meeting using appropriate technology, whether the meeting is held in person or wholly online, and such members shall count as present at the meeting for the purposes of quorum.
