# Code Of Conduct For Adjudicators And Volunteers

#### Statement Of Commitment

The BGDA is committed to the safety and wellbeing of all children and young people, especially those who use our services. Our volunteers will treat all children and young people with respect and understanding at all times and listen to their concerns. To ensure children and young people are kept safe from harm, the following code of conduct for interacting with children and young people applies.

## Who Must Comply With This Code Of Conduct?

This code of conduct applies to all volunteers, including adjudicators and Executive members, who enter our service environment.

### The Standards Of Appropriate Behaviour

Physical Contact	<ul> <li>Allowing for personal space</li> <li>Touching due to medical emergency or protecting from physical harm</li> <li>Non-threatening demeanour</li> </ul>	•Violent or aggressive behaviour including hitting, kicking, slapping or pushing  •Kissing or touching of a sexual nature consistent with 'grooming'
Other	•Appropriate attire/clothing for role •Use of internet/mobile phone for purposes relating to the BGDA whilst adjudicating for the BGDA	<ul> <li>Using alcohol or other substances before or during work</li> <li>Inappropriate clothing</li> <li>Sending inappropriate emails, photos or texts relating to teams, students or other stakeholders of the BGDA to any person</li> </ul>

## Consequences For A Breach Of This Code Of Conduct

In the event that the code of conduct for interacting with children and young people is breached, the BGDA's Executive will take immediate actions consistent with our plan for managing breaches of the child and youth risk management strategy.
